I. Opening Remarks

- 1. Mr LEUNG Kin-man, the Chairman of the Tuen Mun District Council ("TMDC"), welcomed Members of the Traffic and Transport Committee ("TTC") (2018-2019) to the first meeting of the TTC.
- 2. Mr LEUNG Kin-man said that according to the TMDC Standing Orders, a committee should elect its chairman and vice-chairman at the first meeting of the committee in each term, and the TMDC Chairman should preside over the meeting for the election of the committee's chairman and vice-chairman. Therefore, he stated that he would be presiding over this meeting until the Chairman and Vice-chairman of the TTC were elected.

II. <u>Election of TTC Chairman</u>

- 3. Mr LEUNG Kin-man said that Section 71(3) of the District Councils Ordinance provided that a committee of a District Council ("DC") was to elect a member of the committee who was also a member of the DC as the chairman of the committee.
- 4. On 17 November 2017, the Secretariat had sent the membership lists of all the committees and the nomination forms for the chairmen and vice-chairmen of the committees to all Members. The nomination period had closed on 8 December 2017 and the Secretariat had sent the list of the validly-nominated candidates to all Members for reference on 11 December 2017.
- 5. The Secretariat had received one nomination for TTC Chairman by the end of the nomination period. Mr KWU Hon-keung nominated Mr SO Shiu-shing as the TTC Chairman, and the nomination was seconded by Mr Lothar LEE and Mr CHAN Man-wah.
- 6. As there was only one Member nominated as a candidate for TTC Chairman, Mr LEUNG Kin-man announced pursuant to the TMDC Standing Orders that candidate Mr SO Shiu-shing was elected ipso facto as the TTC Chairman for the term starting from the date of this meeting until 31 December 2019.

III. Election of TTC Vice-chairman

7. Mr LEUNG Kin-man stated that pursuant to Order 33(3) of the TMDC Standing Orders, a committee might elect a member who was also a TMDC

Member as the vice-chairman of the committee.

8. The Secretariat had received one nomination for TTC Vice-chairman by the

end of the nomination period. Mr CHAN Man-wah nominated Mr YIP Man-pan

as the TTC Vice-chairman, and the nomination was seconded by Mr Lothar LEE

and Mr Leo CHAN.

9. As there was only one Member nominated as a candidate for TTC

Vice-chairman, Mr LEUNG Kin-man announced pursuant to the TMDC Standing

Orders that candidate Mr YIP Man-pan was elected ipso facto as the TTC

Vice-chairman for the term starting from the date of this meeting until 31 December

2019.

10. As the TTC Chairman and Vice-chairman had been elected, Mr LEUNG

Kin-man handed over the chair to the TTC Chairman.

[The TTC Chairman presided over the meeting from this point onwards.]

11. The TTC Chairman thanked Members for their support and hoped all

Members would continue to offer ideas on matters concerning traffic and transport

in Tuen Mun.

IV. Any Other Business

12. There being no other business, the Chairman closed the meeting at 9:58 a.m.
