**Environmental Hygiene Service Report by
Tuen Mun District Environmental Hygiene Office of
Food and Environmental Hygiene Department
(1.7.2023 – 31.12.2023)**

A. Summary

(1) Illegal hawking and illegal extension of business by shops at Chi Lok Area and San Hui Area in Tuen Mun

Food and Environmental Hygiene Department (FEHD) has all along been taking action to combat illegal hawking and illegal extension of business by shops in the vicinity of Chi Lok and San Hui Area. In order to deter these illegal activities, apart from routine patrol, FEHD will also mount blitz enforcement operations from time to time. During the six-month reporting period, 47 and 89 prosecutions were taken against illegal hawking and illegal extension of business by shops in Chi Lok area and San Hui area respectively, a total of 136 prosecutions have been instituted. Continuous efforts and appropriate actions would be taken to monitor the situation at the area.

(2) Prevention of cholera

During the six-month reporting period, no case of cholera was recorded in Hong Kong. To monitor the quality of seawater for keeping live seafood in seafood retail outlets, FEHD has taken a total of 192 informal fish tank water samples from Tuen Mun District for microbiological analysis and 2 of the samples were found unsatisfactory. 2 formal follow-up samples were taken for microbiological analysis and 1 of which was still found unsatisfactory. Prosecution action was taken against seafood retail outlet. Analysis result of the follow-up formal sample taken from that retail outlet was found satisfactory.

(3) Removal of unauthorized bills and posters

FEHD has made continuous efforts to remove unauthorised bills and posters put up in public places. During the six-month reporting period, a total of about 19 700 bills and posters were removed by FEHD staff.

(4) Use of easy-mount frames and placards to display bills and posters in public places without permission

During the six-month reporting period, FEHD has launched 12 and 23 operations at two blackspots, namely on the walkways at Tuen Mun Cultural Square and in the vicinity of Leung King LRT Station respectively. A total of 4 easy-mount frames and posters were removed during the operations. Continuous efforts to the two blackspots as mentioned, among others, will be taken to ensure environmental hygiene and passageways free from obstruction.

(5) Nuisance caused by food premises with obstruction to public place and unauthorized extension of food business

FEHD has been taking rigorous law enforcement actions to curb illegal extension of business areas caused by food premises. During the six-month reporting period, a total of 109 prosecutions against food premises, 101 were taken out for obstruction to public place and 8 were taken for unauthorized extension of food business.

(6) Sale of meat from non-approved sources

During the six-month reporting period, FEHD has made 44 blitz operations against fresh provision shops and meat retail outlets but no irregularity was found.

(7) Unlicensed hawkers and street obstruction

FEHD has been taking enforcement actions against unlicensed hawkers and illegal extension of business caused by shops. During the six-month reporting period, a total of 170 offenders were prosecuted and 67 cases of seizure were instituted against illegal hawkers.

(8) Pest control

During the six-month reporting period, FEHD has eliminated a total of 3 608 rodents (please refer to Annex I for the details).

The 10-week Second Phase of Anti-rodent Campaign 2023 in Tuen Mun was started on 3 July 2023 and ended on 8 September 2023. The Operation aims to arouse public awareness on the significance of rodent prevention and control in the community, to promote participation of the public in rodent prevention and control work in their premises and to reduce rodent population in the territory, particularly in the target areas and their peripheries. FEHD has strengthened rodent disinfection work at problematic spots including rear lanes, refuse collection points, markets and peripheral areas of construction sites, etc. Subsequently, an eight-week Second Phase of Strategic Anti-rodent Operations 2023 was started on 18 September and ended on 10 November. The Operation aims to enhance the effectiveness of rodent prevention and control work at district level and boost public support and participation in the anti-rodent work. FEHD has strengthened rodent disinfection work at problematic spots with a view to improving the situation thereat.

On the other hand, the Thematic Mosquito Prevention and Control Special Operation 2023 (Phase II) was completed on 14 July 2023. Subsequently, the 12-week Anti-mosquito Campaign 2023 (Phase III) was conducted from 7 August 2023 to 27 October 2023. The Campaign aims to heighten public awareness of the potential risk of dengue fever, Zika virus infection, Japanese encephalitis, chikungunya fever and other mosquito-borne diseases; encourage community participation and forge close partnership of government departments concerned in mosquito prevention and control work; and eliminate potential mosquito breeding sites. During the Campaign, the FEHD will conduct a series of operations to remove stagnant water and prevent mosquito infestation at potential mosquito breeding sites in the district, particularly human residences, schools, construction sites, public housing estates, hospitals, illegal cultivation sites, waterfront public and private cargo working areas, cross boundary check points, typhoon shelters and cross boundary ferry terminals.

In response to the positive gravidtrap index, FEHD has enhanced a series of mosquito control works, prosecution actions and remind concerned departments and organizations to enhance mosquito control. FEHD has also conducted joint operations with concerned parties to those areas with positive gravidtrap indices as to eliminate potential mosquitoes breeding places and offer technical advices. FEHD would continue to organize interdepartmental task force meeting and promotion activity to strengthen public awareness on mosquito prevention and control.
