Air Quality Health Index of Tuen Mun Air Quality Monitoring Station

2024/Jan-Feb

The Environmental Protection Department (EPD) launched on 30 December 2013 the Air Quality Health Index (AQHI) to replace the Air Pollution Index (API), which had been used from 1998. The AQHI informs the public of the short-term health risk of air pollution and helps them take precautionary measures for health protection.

When the health risk category reaches High (AQHI reaches "7"), people who are sensitive to air pollution (including children, the elderly and people with heart or respiratory illnesses) are advised to take precautionary actions. Therefore, we provide below information on the days with the health risk category reaching "High" or above at Tuen Mun station.

From 2014 to 2023, the number of hours with AQHI at "7" or above (i.e., "high" health risk category or above) recorded at Tuen Mun Air Quality Monitoring Station continued to decrease: 220 hours (or 2.5%) were recorded in 2023, which is lower than 519 hours (or 5.9%) in 2014, reflecting the continuous improvement of air quality in Tuen Mun in recent years.

In January and February 2024, Tuen Mun station recorded 5 days with AQHI reaching "7" or above. Details are shown as follows:
