### 書面回應

#### 有關「建議優化颱風前後的安排」

屯門地政處（下稱「地政處」）會於每年暴雨及颱風季節來臨前發信提醒各短期租約租賃人檢查租約用地範圍內所有樹木的狀況，以評估樹木會否對公眾安全產生任何潛在風險，並作出適當跟進。就最近一次超強颱風樺加沙襲港前，地政處亦有發信提醒短期租約露天停車場經營者（下稱「經營者」）注意停車場水浸風險，以及做好一切防風、防水浸準備，並建議經營者及早提醒車主停車場可能存在的水浸風險，建議車主暫時將車輛遷移至較安全的地方停泊，以減低財物之損失。

為應對颱風期間可能出現的突發事故，地政處會於颱風期間安排職員當值，以便在有需要時向相關部門或市民提供適切協助。

另外，政府有提供不同的援助基金予受災人士，當中有不同的種類，由不同的部門審批。申請人可自行選擇合適的援助基金，詳情請參閱附件。

# 簡介Information

「緊急救援基金」是根據《緊急救援基金條例》（香港法例第1103章）的規定而設立的信託基金。

The Emergency Relief Fund Ordinance, Chapter 1103 of the Laws of Hong Kong, provides for the establishment and administration of the Emergency Relief Fund.

---

基金旨在提供經濟援助給因火災、水災、暴風雨、山泥傾瀉、颱風及其他天然災害，而需要緊急救援的人士。基金屬援助而非賠償性質。

The Fund aims to provide financial assistance to persons who are in need of urgent relief as a result of fire, flooding, tempest, landslide, typhoon or other natural disasters. Grants from the Fund are intended for relief rather than compensation.

任何因罪行（例如縱火）或蓄意疏忽（例如違反海事規例）而導致的災難，均不會獲發基金。

No payment will be made in respect of any occurrence resulting from a criminal act (e.g. arson) or an act of deliberate negligence (e.g. breach of marine regulations).

---

社會福利署署長法團是基金受託人。批核申請及發放款項的工作，大多由社會福利署、地政總署、海事處及漁農自然護理署負責，而民政事務總署則負責地區層面的全面統籌工作。至於各補助項目的申請，則須在列載於背頁的有關期限內提出。

The Fund is vested in the Director of Social Welfare Incorporated as Trustee. The responsibility for approving grants and making payments is in most cases vested with the Social Welfare Department, Lands Department, Marine Department, and Agriculture, Fisheries and Conservation Department, while the Home Affairs Department is responsible for overall co-ordination at the district level. Applications for various types of grants must be made within the respective time limits as shown overleaf.

Payments are made on the basis set out in the Emergency Relief Fund Payment Schedule, which is available for reference at the District Offices of the Home Affairs Department.
