## The Meeting

### I Opening Remarks and Introduction

The Chairman welcomed the Members and representatives from the government departments to the 7<sup>th</sup> meeting of the Culture, Recreation and Sports Committee (CRSC).

2. The Chairman said that Mr LAM Faat-kang, Mr LI Hung-por and Ms MAN Mei-lan were absent with apologies.

3. The Chairman reminded Members that according to section 28 of the Tsuen Wan District Council Standing Orders (the “Standing Orders”), unless otherwise agreed by the Chairman, each Member could speak and make supplementary remarks once for each agenda item at the meeting. Each Member could speak up to three minutes each time.

4. The Chairman reminded Members that according to section 15(3) of the Standing Orders, “in the course of a meeting of the Council, all persons attending or sitting in on the meeting at the place of the meeting shall switch off all devices which may emit sound and shall not use any telecommunications devices for conversation” in order to ensure the smooth progress of the meeting.

### II Item 1: Confirmation of Minutes of the Meeting held on 10.11.2016

5. The minutes of the previous meeting were unanimously confirmed by Members without amendment.

### III Item 2: Matters Arising from the Minutes of the Previous Meeting

6. The Chairman said that there were no matters arising from the minutes of the previous meeting.

### IV Item 3: Work Progress Report of Various Working Groups under the Committee and Sponsored Organisations

#### (A) Culture, Arts, Recreation & Sports Development Group

7. Mr CHAN Chun-chung, Jones reported that the “4th Melodious Voice from Tsuen Wan Singing Contest - Grand Final and Winners’ Concert”, which was co-organised by the Culture, Arts, Recreation & Sports Development Group (the Group) and the Residents Association of Tsuen Wan Hoi Bun District, would be held at the Auditorium of Tsuen Wan Town Hall on 15 January 2017. Besides, the remaining co-organised activities of the Group were held successfully.

#### (B) Working Group on Activities under Cultural, Recreation and Sports Committee

8. The Chairman reported that all the four activities co-organised by the Working Group on Activities under Cultural, Recreation and Sports Committee and local organisations for the current year were held successfully.

(C) Tsuen Wan Culture and Recreation Co-ordinating Association (TWCR) (Sponsored Organisation)

9. The Chairman said that the TWCR had no special business to report.

(D) Federation of Tsuen Wan District Sports and Recreation Association (TWDSRA) (Sponsored Organisation)

10. Mr YAU Kam-ping reported that the TWDSRA Shield Bowling Competition 2017 organised by the TWDSRA would be held at the Magic Fun Bowling World, Tsuen Wan on 22 January 2017.

(E) Tsuen Wan Sports Festival Co-ordinating Committee (TWSFCC) (Sponsored Organisation)

11. The Vice Chairman reported that seven events in the 27th Tsuen Wan Sports Festival were held successfully so far, namely the Opening Ceremony cum Adventist Hospital 10K Run for Healthy Heart 2016, Tsuen Wan Rural Committee Elite Soccer Competition, Tsuen Wan Area Inter-Primary School Table-Tennis Competition, Tsuen Wan Area Primary School Nine-a-side Soccer Competition, Tsuen Wan Area Inter-school Badminton Competition, DanceSport Championships and Rugby Competition cum Fun-day. The Closing Ceremony cum Lion Dance Competition would be held at Tsuen King Circuit Sports Centre on 15 January 2017. Moreover, the TWSFCC would prepare the commemorative publication of the 27th Tsuen Wan Sports Festival for Members and co-organisers' retention in due course.

(F) Tsuen Wan Football Association (TWFA) (Sponsored Organisation)

12. The Vice Chairman reported that the TWFA ranked 12th in the Third Division of the District Team League for the time being. The TWFA would continue to strive for a higher ranking in the remaining matches.

V Item 4: Any Other Business

(A) Report on Preparatory Work of the 6th Hong Kong Games

13. The Chairman reported the latest progress of the preparation work for the 6th Hong Kong Games (HKG), including the selection of Tsuen Wan District Team, Cheering Team trainings, arrangements for district sponsorship and the course of competition held in the "Jockey Club Vitality Run" on 8 January 2017.

14. The Chairman reported that the Secretariat had received a written notice of cancellation of the excursion and relevant funding application from the Owners' Corporation of Block 1 of Harmony Garden.

15. Members noted the contents of the two information papers as follows:

- (1) Financial Statement of Culture, Recreation and Sports Committee as at 23 December 2016 (CRSC Paper No. 26/16-17); and

- (2) Application for Funds by District Organisations for Excursions held between 1 October and 31 December 2016  
(CRSC Paper No. 27/16-17).

16. The Chairman reminded Members that the next meeting was scheduled on 9 March 2017 and the deadline for submission of paper was 22 February 2017.
