The Meeting

I Opening Remarks and Introduction

The Chairman welcomed the Members and representatives from the government departments to the 8th meeting of the Social Services and Community Information Committee (SSCIC).

2. The Chairman said that Mr KOO Yeung-pong and Mr CHAN Sung-ip were absent with apologies.

3. The Chairman reminded Members that according to section 28 of the Tsuen Wan District Council Standing Orders, unless otherwise agreed by the Chairman, each Member could speak and make supplementary remarks once for each agenda item at the meeting. Each Member could speak up to three minutes each time.

II Item 1: Confirmation of Minutes of the Meeting held on 13.1.2017

4. The minutes of the previous meeting were unanimously confirmed by Members without amendment.

III Item 2: Matters Arising from the Minutes of the Previous Meeting

5. The Chairman said that there were no matters arising from the minutes of the previous meeting.

IV Item 3: Work Progress Report of various Working Groups under the Committee

(A) Working Group on Integrated Community Services

6. The Vice Chairman reported that a total of 24 activities on youth, education, community promotion, women matters and community hall were organised by the Working Group for the current year. All the activities concluded successfully.

(B) Working Group on Age-friendly Community and Rehabilitation

7. Mr WONG Wai-kit reported that the “Cantonese Operatic Songs Concert” co-organised by the Working Group and Tsuen Wan District Elderly Welfare Association was successfully held on 24 February 2017. Members’ support to the activity was appreciated. Moreover, a total of 18 elderly and rehabilitation activities were organised by the Working Group for the current year. All the activities concluded successfully. Besides, the Working Group would convene a meeting on 17 March 2017 to discuss and report on the latest progress of the Jockey Club Age-friendly City Project.

V Item 4: Any Other Business

(A) Funding Scheme for Promoting the Culture of Low Salt-Low-Sugar Diets in the Community

8. The Chairman said that as informed by the Tsuen Wan District Council earlier, the Committee on Reduction of Salt and Sugar in Food would launch the “Funding Scheme for Promoting the Culture of Low-Salt-Low-Sugar Diets in the Community” in the current year. A sum of \$250,000 would be allocated for each of the 18 District

Councils to launch projects to promote low salt and sugar food culture in the districts. He proposed that the Working Group on Integrated Community Services should follow up the above matters.

9. Members unanimously agreed to the above arrangement.
