

Suggestion for Appointment to Hospital Governing Committee of Tin Shui Wai Hospital

Based on the District Council's suggestion, Mr TANG Cheuk-him has been appointed by the Hospital Authority (HA) Board as member of the Hospital Governing Committee (HGC) of Tin Shui Wai Hospital (TSWH) in personal capacity, with the current term expiring on 31 March 2020. I therefore write to invite your suggestion of a suitable candidate from members of your District Council for consideration of appointment as member of the TSWH HGC in personal capacity for the two-year term from 1 April 2020.

In accordance with Schedule 3 of the HA Ordinance, the functions of an HGC are to (a) advise the Authority of the needs of individual hospitals to provide hospital services to the public and of the resources required to meet those needs; and (b) oversee the management of the hospital in ways which are conducive to optimising the utilisation of resources, improving hospital environment and attracting, motivating and retaining qualified staff.

HA appoints community members, including from District Councils, for community involvement in the work of HGCs among other members with different expertise, professional experience, contribution etc. Community members are appointed to serve on HGCs in personal capacity,

Members of HGCs may also be appointed to sorve in the relevant Regional Advisory Committee which comprises representatives from public hospitals in the region among other groups in its membership as prescribed in Schedule 3 of the HA Ordinance.



and members of HGCs are expected to actively participate in HGC meetings (normally on quarterly basis) and other HGC activities. In appointing community members to HGCs, the Authority considers the individual's profession and expertise, interest in health services, and their involvement in community or district organisations, as well as other relevant guidelines of HA.

A data form is enclosed at the <u>Annex</u> for suggestion of a member from your District Council for consideration of appointment as member of the TSWH HGC. All information provided will be handled in strict confidence. If you need more information on the general operation of HGCs, please contact Ms Phoebe LEUNG, Manager (Boards & Support), at 2300 6975.

Subject to the approval of the HA Board in late February 2020, we shall issue formal appointment letters to HGC members, with copy to the District Council concerned for information. We take this opportunity to express our sincere thanks to the District Council for continued support to HA and public healthcare.

Thank you for your kind attention and assistance. I look forward to your suggestion before Friday, 31 January 2020, and your early reply would be much appreciated.

These requirements are set out in paragraphs 5 and 17 of Schedule 3 of the Ordinance.

Our staff members at the HA Secretariat, Boards and Support Department may also ask you to provide your personal data for purposes related to your appointment as a Member of the HA Board/any of its committees on your first joining the HA and annually thereafter.

When you provide personal data to us, please make sure that the data is accurate and complete. If you do not provide the information requested or if the information provided is inaccurate or incomplete, our consideration of the purposes stated above or generally in respect of your appointment as a Member will be affected.

Please note that your personal data may be made available to:

- appropriate persons in the HA;
- any other relevant parties who require it for matters related to the purposes of your appointment as a Member of the HA Board/any of its committees; or
- any relevant government departments/appropriate authorities when the HA is required to provide it under the relevant legislation for use for the purposes of that legislation.

In addition to the above, we will only use, disclose or transfer the personal data you provide to us:

- for those purposes relating to your appointment as a Member of the HA Board/any of its committees/subcommittees; or
- where permitted by law.

We will obtain your consent before using your personal data for any other purposes.
