We (MALAYALI ASSOCIATION LIMITED) had been registered in April 11, 2013 as a Non-Profit making Company.

We are a South Indian minority community in Hong Kong. Even though the people from our state (Kerala State) had been in Hong Kong from early 1960's and they used to organize some function, this is the first time that we are in the form of a registered non-profitmaking organisation.

September is the biggest harvest festival in our State, and it's our New Year too, the festival called "ONAM". We are organising different kinds of stage programs by the members and their kids, also few invited guests (ministers /artists) will participate in this event.

Last year (September 14, 2014) we had done the same festival in "Henry G Leung Community Center". We had used our associate organisation "KERALA SAMAJAM" to book this hall. I am the President of both associations. Now we are using "KERALA SAMAJAM" only for charity works and "MALAYALI ASSOCIATION LTD" for Cultural activities. Former Bar Council Chairperson Mr Kumar Ramanathan, was our chief guest in Henry G Leung hall in last year, Mr Kumar Ramanathan is a member in our association.

The program will be from Morning to evening and there will be a lunch supplied to the members. This cooked food will bring from outside and no re-heat process will conduct in the hall or any other vicinity. No alcoholic drinks serve, food will be rice and vegetable curries.

Here by confirm that, we will take care the facilities of the Hall and will clean it and keep the things in the proper place before we leave the venue. We had been accordingly arranged our program schedule, to get enough time to do the cleanup work.
